  - 2. Skunk Hill Solar: Goat Rocks. Johnson attended hearing on 12/7, John Brown spoke. Next meeting in March.
  - Bradford dam property, was informed of a preliminary application for subdivision has been submitted to the Planning Department. Johnson will inquire further.

- 4. Friends/HLT: Dec 2 work party took place at Pelloni property, Friends attended as well as Trustees, trail clearing was done for main trail. GPS mapping is planned in the spring for side trails, still not well marked.

  - ii. Grills Preserve: Grant contacted Ken Ayers at RI Dept of Agriculture, regarding our planned brush clearing / invasive removal project as they have easement on the property. Amanda Cugno, DEM Fish and Wildlife habitat looking at it. Will let Thompson/Tuthill know to hold off invasive removal until we get DEM sign off.
