Instructions for Corporation Applicants

1. Every question on Application Form must be answered. Any false statements made by the Applicant will be sufficient grounds for the denial of the application or the revocation of the license in case one has been granted. The Corporate Seal must be affixed.
2. Corporations having 25 or more stockholders need not file a list of the names and addresses of stockholders – (Question 8 of application).
3. Attention is called to the requirements of the 1963 amendment of Section 3-5-10 of the General Laws.
 - (a) All newly elected officers or directors must be reported to the Board of License Commissioners within 30 days.
 - (b) Any acquisition by any person of more than ten percent (10%) of any class of corporate stock must be reported within 30 days.
 - (c) Any transfer of more than fifty percent (50%) of any class of corporate stock can be made only by written application to the Licensing Board subject to the procedures for a transfer of a license.
